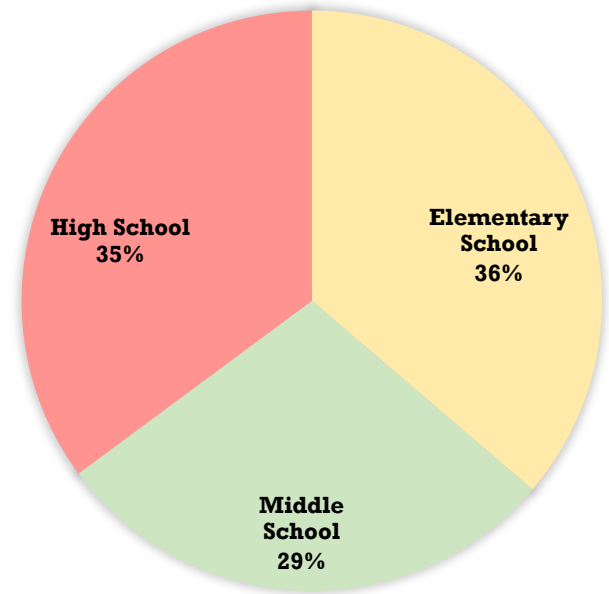

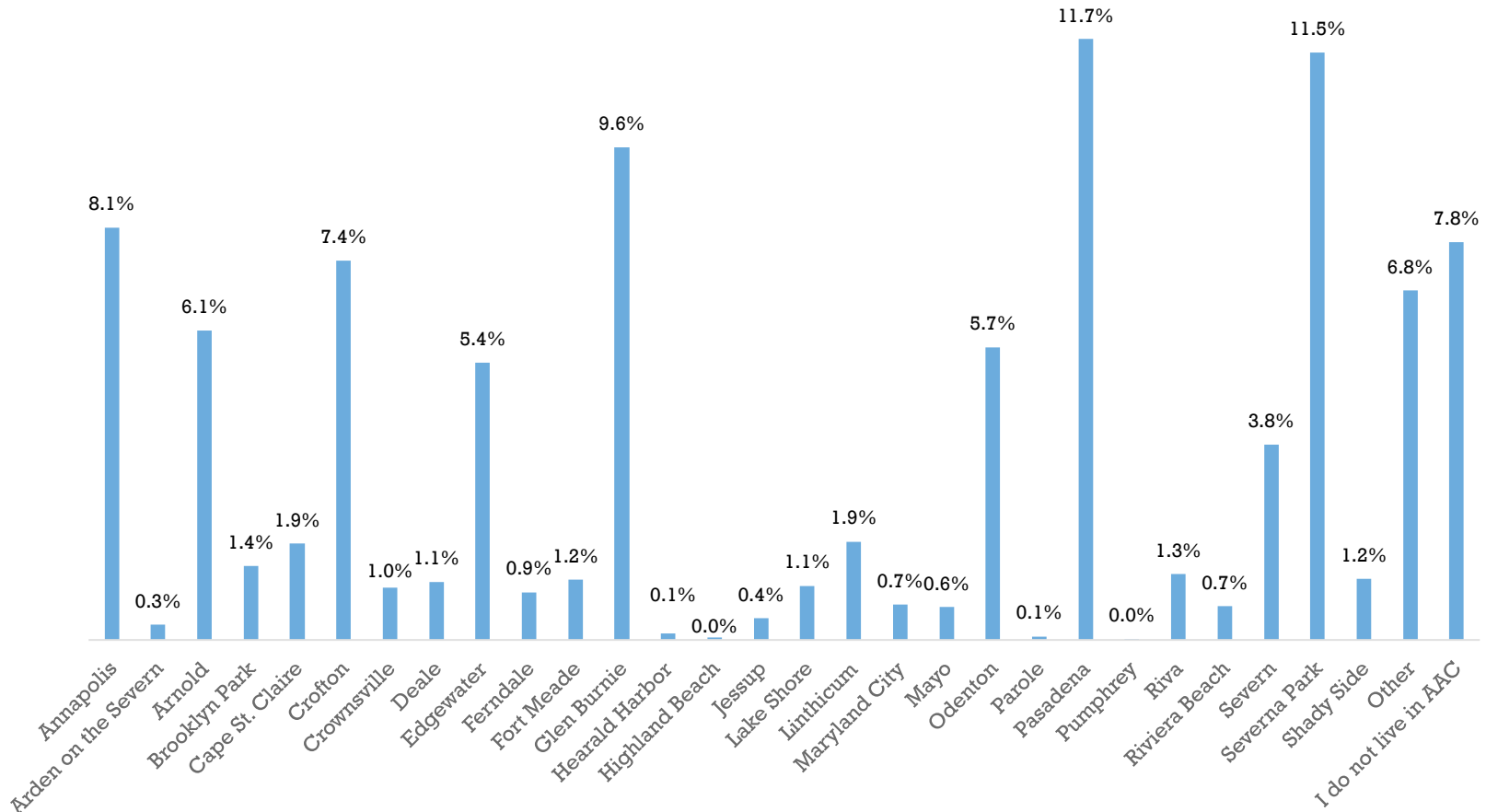

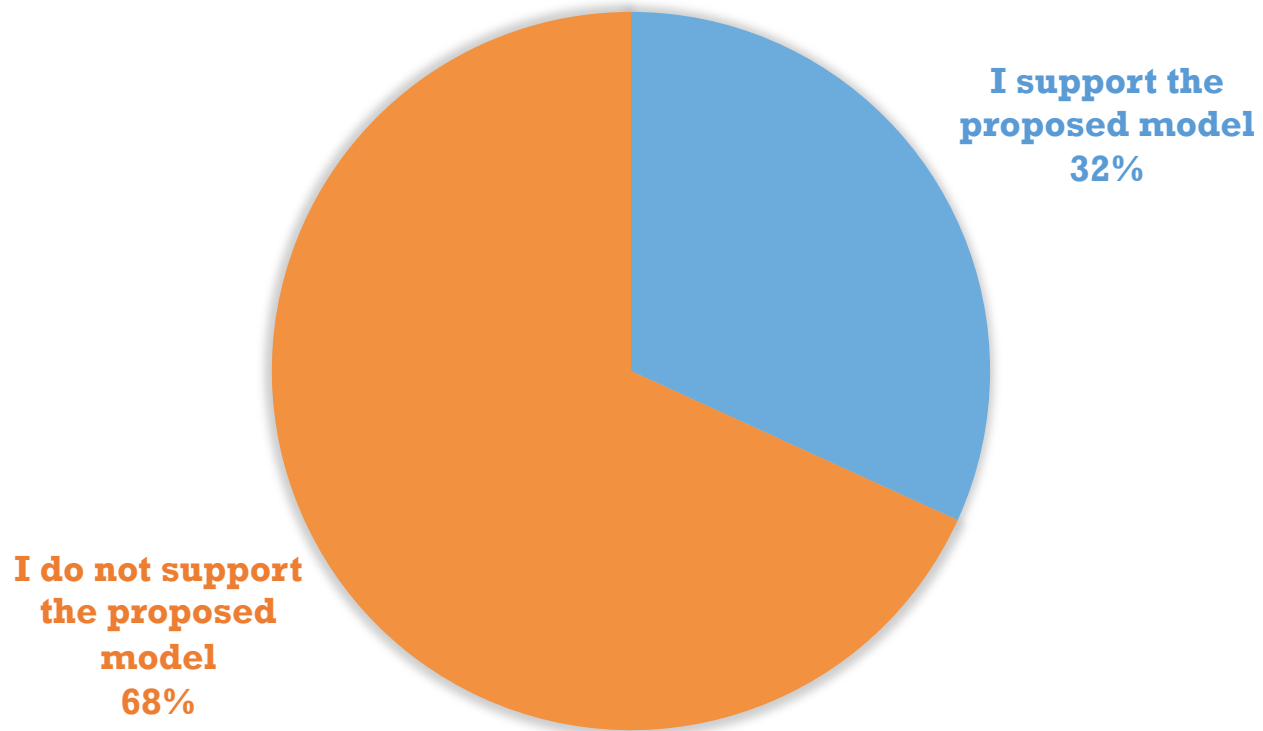
Communities Represented\*



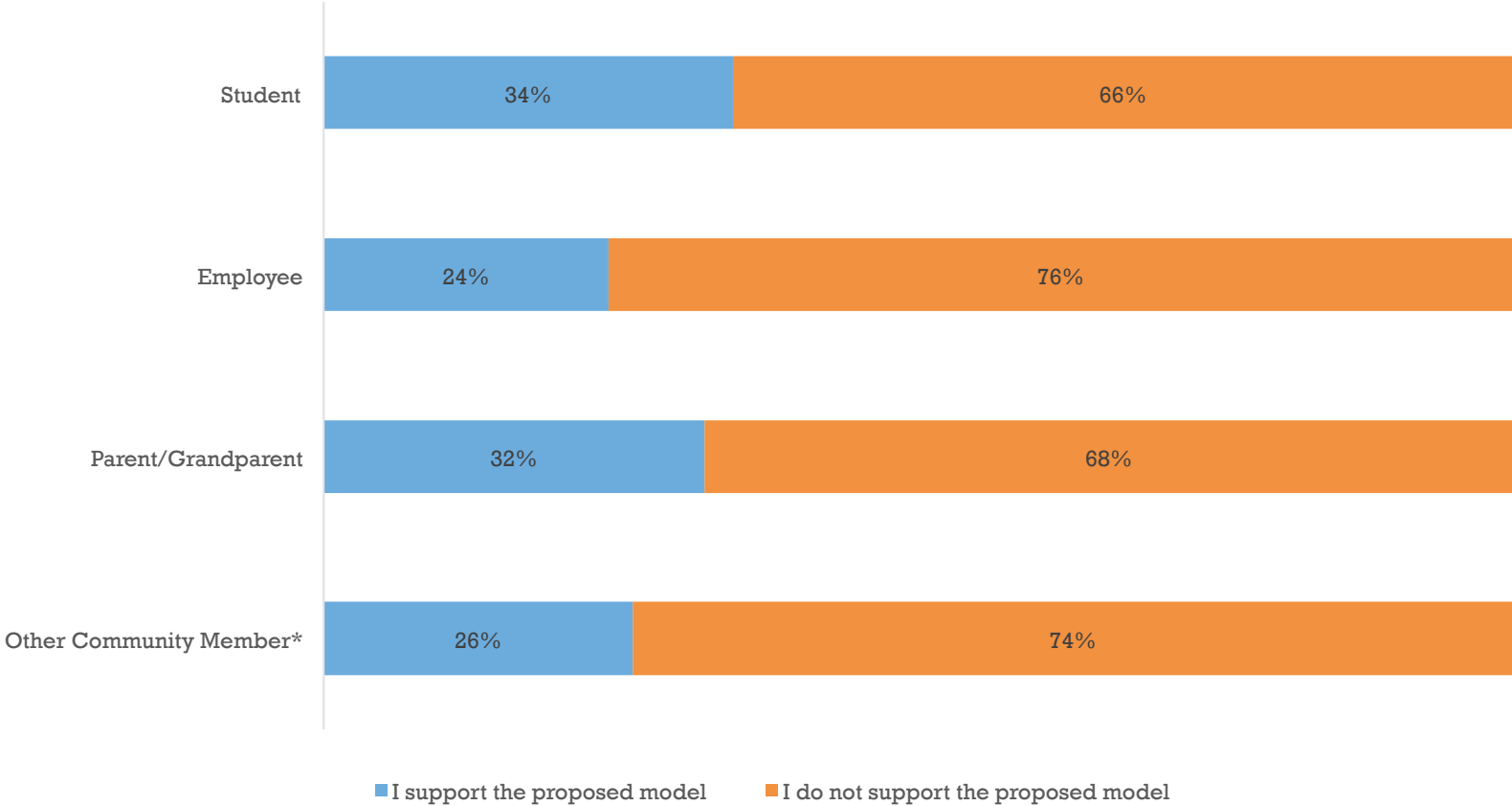

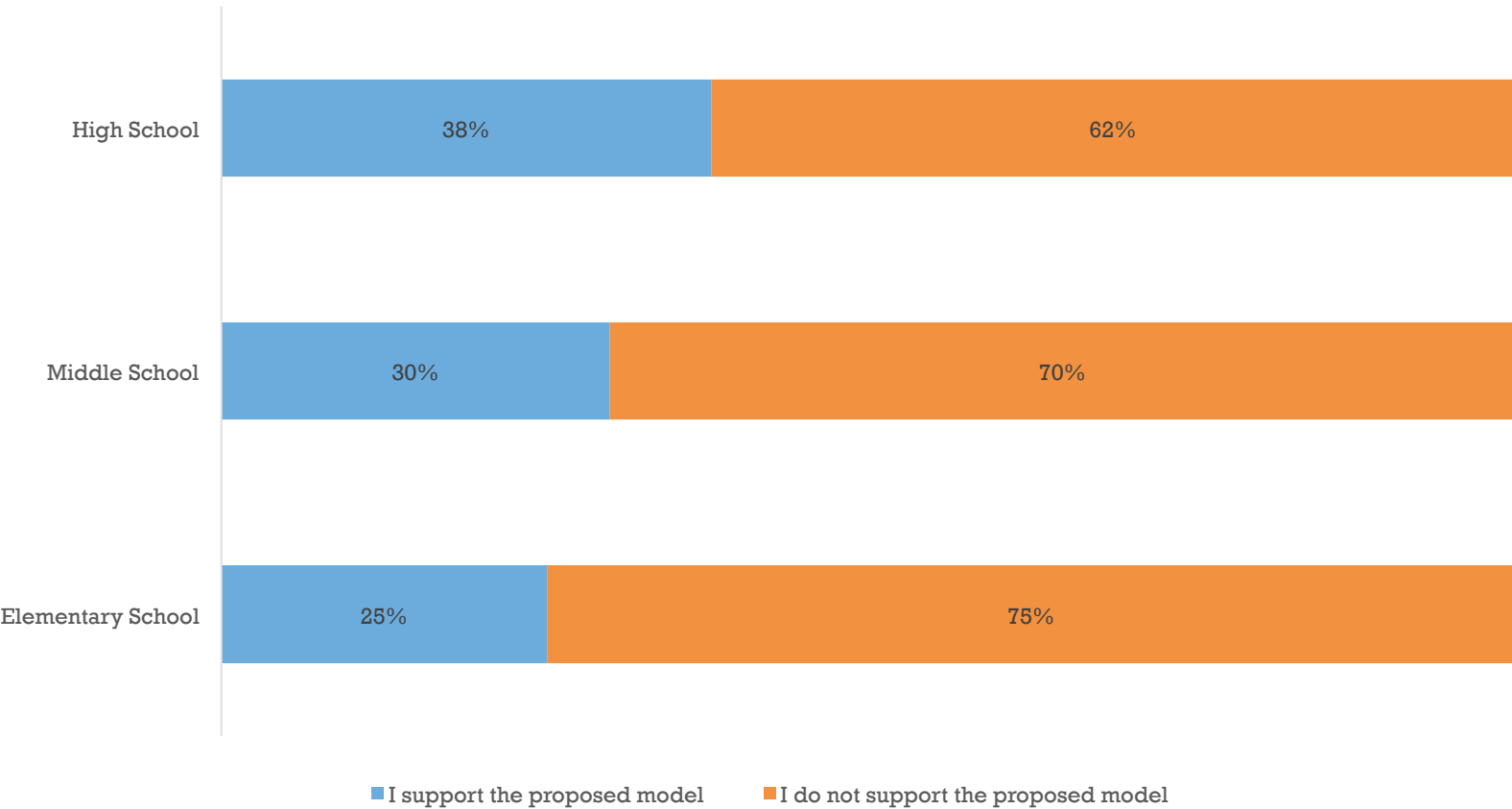


# OVERALL RESPONSE BY STAKEHOLDER

# REASONS BEHIND RESPONSE

When completing the survey, each respondent was asked to indicate the reason(s) for why they did or did not support the proposed model for change in school start and dismissal times in 2017-2018.

## I support the proposed model

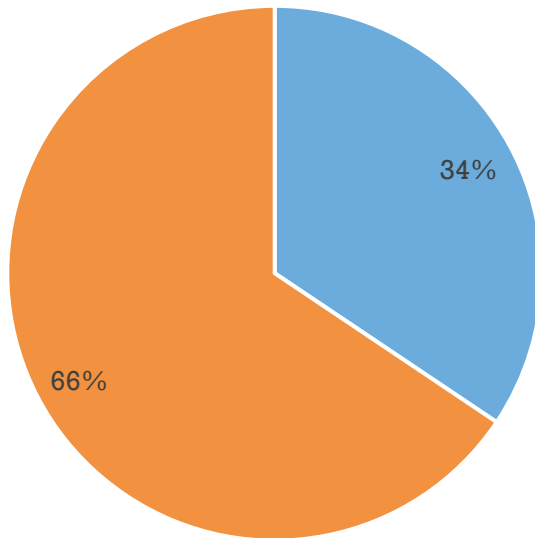
Reason	% of Responses
Improved student mental health	20%
Improved student physical health	17%
Increased student academic achievement	17%
Increased student safety (traveling in daylight to school)	15%
Improved student school attendance	12%
Decreased traffic accidents involving teen drivers	9%
Decreased middle school unsupervised time after school	7%
Decreased need for morning child care	4%

## I do not support the proposed model

Reason	% of Responses
Current school start & dismissal times are fine for my family/stakeholder group	19%
Increased after-school activity/athletic challenges	15%
Decreased family time in the evenings	15%
Increased need for before/after school child care—limited availability	12%
Increased need for before/after school child care—increased cost	11%
Decreased student safety (traveling in darkness to or from school)	10%
Increased student employment challenges	9%
Increased transportation concerns/challenges for Special Centers & Magnet Programs	8%

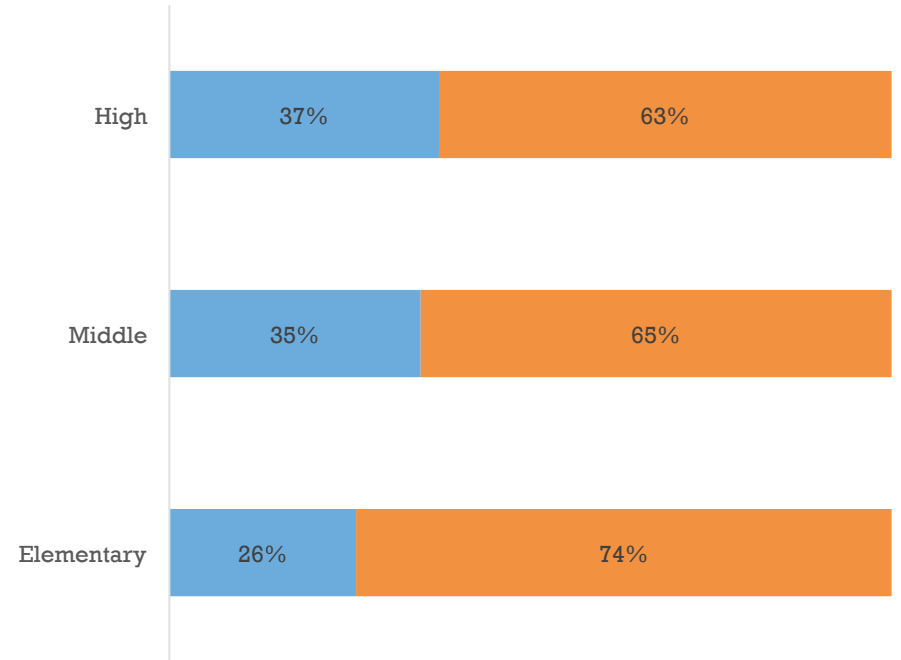
Student Overall Response

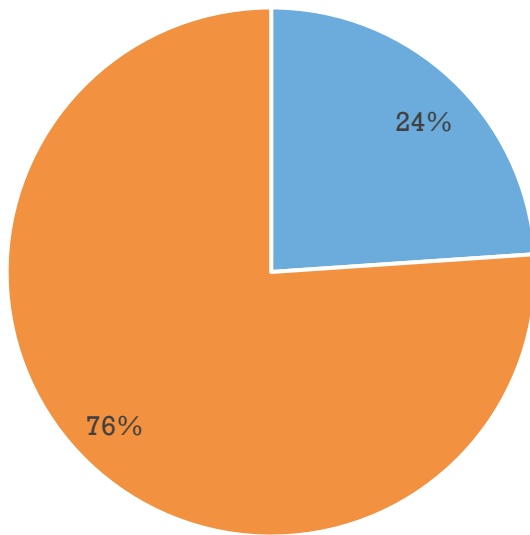

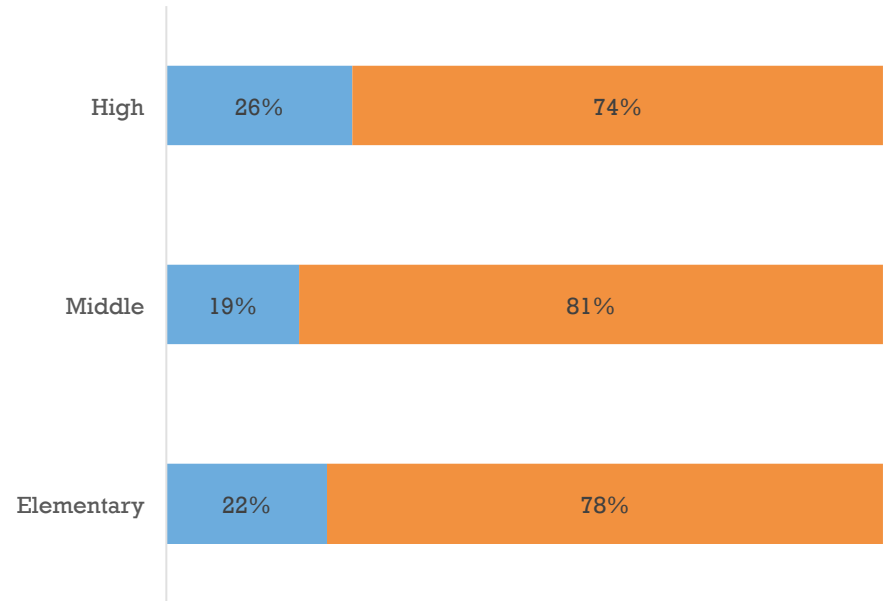
## Overall Employee Response

## Employee Response by Grade Level



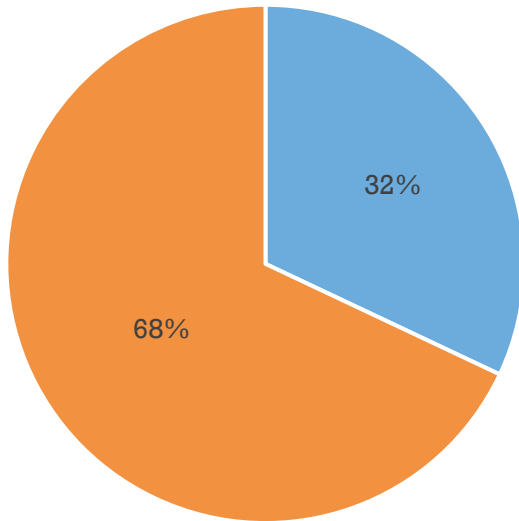

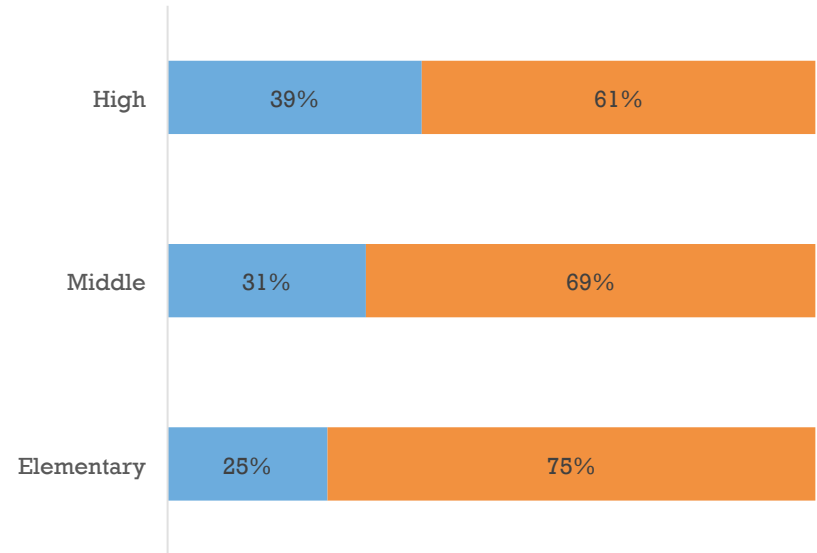
Overall Parent/Grandparent Response

Parent/Grandparent Response by Grade Level



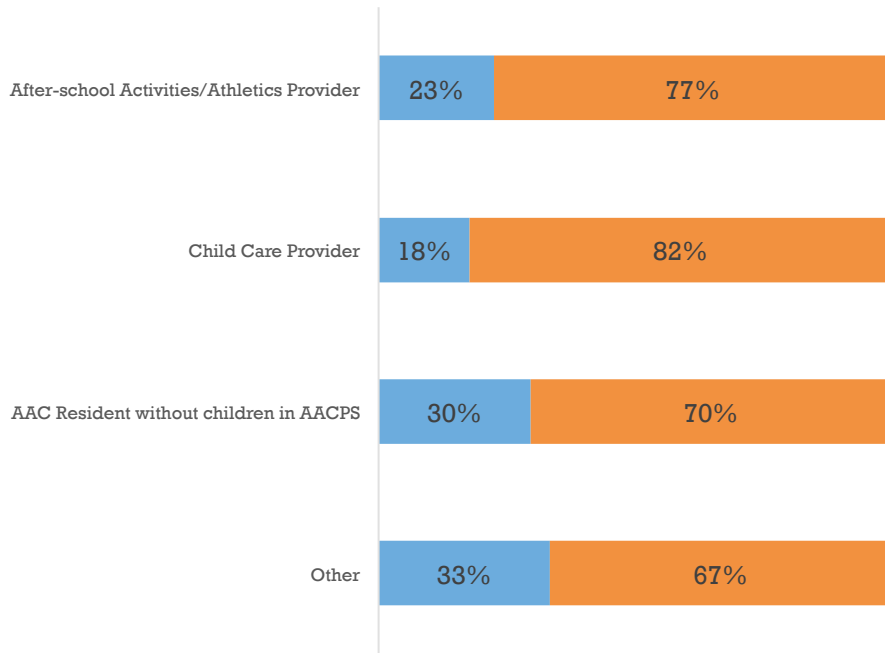

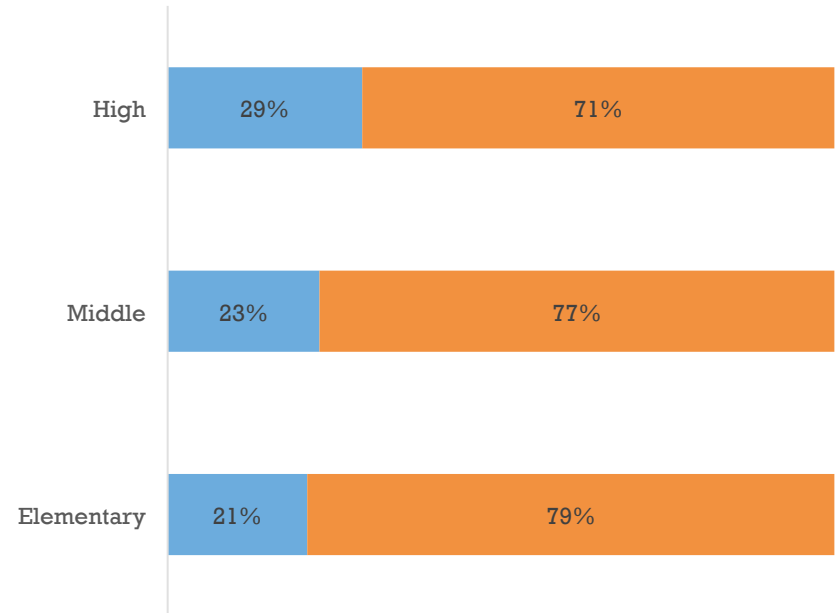
